

TERMS & CONDITIONS FOR ILOOMINATION MODEL SHOWCASE PUBLIC VOTING LUCKY DRAW

- A. ILOOMINATION (the “**Contest**”) is a design challenge organised by the National Environment Agency (“**NEA**”), aimed at engaging students of Singapore’s Institutes of Higher Learning to design clean and safe public toilets.
- B. The shortlisted top 3 teams (“**Finalists**”) will work on the production and fabrication of their virtual models which will be showcased publicly on www.cgs.gov.sg/iloomination (the “**Website**”) for public voting.
- C. Members of the public can vote for their favourite design via an online voting form on the Website between 27 August 2021 and 5 September 2021, and five members of the public will be selected at random to win S\$40 worth of NTUC FairPrice vouchers each. The public votes will contribute to 20% of the total score during the final round of the Contest.
- D. The Finalists will present their proposals and virtual models at a final presentation in September 2021 to the Judging Panel who will select the winners for the 1st, 2nd and 3rd prizes respectively.

By participating in the Draw, you (“**Participant**”) acknowledge and are deemed to have read, understood and agree to be bound by all the Terms and Conditions set out herein by the organiser, NEA:

Voting and Lucky Draw Period

1. Public voting commences on 27 August 2021, 0000 hours and ends on 5 September 2021, 2359 hours. NEA reserves the right to extend the voting period as may be required.

Eligibility and Entry Procedure

2. To enter and qualify for the public voting lucky draw (the “**Draw**”), Participants are required to submit their vote and personal particulars (in the compulsory fields marked with asterisks) via the online voting form on the Website. Any incomplete entries will result in automatic disqualification of the participant(s).
3. All Singapore citizens, permanent residents and foreigners who are staying or working in Singapore, holding a valid student pass / employment pass / dependent pass / work permit, save for employees of NEA, their immediate family members (i.e. spouse and children) and any other parties directly involved in organising, promoting, administration and execution of the Draw, are entitled to participate in the Draw.
4. Participants may submit more than one vote.

Personal Data

5. Participants consent to collection of his/her personal particulars by NEA and authorised agencies and vendors for verification purposes.

Lucky Draw Selection Process

6. The Draw will be conducted virtually on 1 October 2021 at 1500 hours, unless determined otherwise by NEA. NEA shall be under no obligation to notify the Participants regarding any change in date, timing or venue of the Draw.
7. Five Participants will be selected ("**Winners**") and each Winner will be entitled to S\$40 worth of NTUC FairPrice vouchers ("**Prize**").
8. Winners will be contacted over the phone or email as listed in the online voting form by 8 October 2021. NEA accepts no responsibility for any inability or failure to contact the Winner arising from inaccurate and/or incomplete contact information.
9. NEA reserves the right to conduct a re-draw in the event that:
 - a) The Winner fails to meet the Terms and Conditions and/or any rules and regulations;
 - b) NEA is unable to contact the Winner;
 - c) The Winner fails to respond to NEA or notifies NEA that he/she does not wish to claim the Prize;
 - d) The Winner has committed any act of fraud or dishonesty, or has misrepresented anything in connection with the Draw; or
 - e) The Winner is deceased or is mentally incapable.

Prizes and Redemption

10. NEA reserves the right to substitute or replace the Prize with another prize of similar value without prior notice.
11. Prizes are non-transferable, non-negotiable and non-exchangeable.
12. Winners are required to present their identification (e.g. NRIC/FIN, passport, driving licence) for verification purposes when collecting the Prizes. Winner(s) may be required to sign a declaration form upon collection of the Prize.
13. Winners shall bear all costs associated with the claiming and collection of Prizes from NEA.
14. NEA shall not be responsible for any consequences including, but not limited to loss of life, injury to person and/or damage to property, arising from or in connection with the Contest, the Draw and/or redemption or use of the Prize.

General

15. NEA shall not be responsible for any late, lost or misdirected voting submissions, or any loss or damage, including delays and/or failure of any electronic or telecommunication systems due to (without limitation) technical faults and/or network disruptions/congestions or any technical or human error which may occur during the registration and/or administration of the Draw. NEA is not

responsible for any electronic transmission errors resulting in omissions, interruptions, deletions, losses, or delays in transmission or operation. NEA is not responsible for any kind of technical, network, telephone system, electronic equipment, computer, hardware, or software dysfunction or limit resulting in theft, destruction, unauthorised access, or change to the Contest and Draw kit. NEA is not responsible for any kind of technical problems, traffic congestion, or any combination on the website resulting in inaccurate transmission or non-display of the Contest and Draw kit. In the event that a computer virus, bug, tampering, unlawful intervention, foul play, technical malfunction, or other cause results in an inability to carry out the internet portion of the Contest and Draw as planned, and/or if the operation management of the Contest and Draw, security, fairness, integrity, or appropriateness of the implementation is hindered, or affected, NEA reserves the right to, and has the sole discretion to cancel, end, change, or suspend the Contest and Draw.

16. Participants shall fully indemnify NEA and hold NEA harmless from and against any and all claims, actions, losses, damages, liabilities, costs, and expenses, including attorneys' fees and other legal expenses arising directly or indirectly from or in connection with, (a) any breach by Participant of these Terms and Conditions; (b) any failure of Participant to comply with all applicable laws; (c) any violation of any rights any of third party related to Participant's entry; and (d) Participant's fraud, negligence or wilful misconduct.
17. Participants must be responsible for providing complete and accurate information to NEA.
18. Participants agree that any and all personal data provided to NEA and its third party vendors may be used and/or disclosed by NEA and its third party vendors for the following purposes:
 - a) Communication with the winners for purposes related to this Contest and Draw and related activities; and
 - b) Publicity, advertising or marketing purposes in connection with the Contest and Draw and related activities.
19. Each Winner of the Draw consents to the public disclosure of his/her name and any photographs, videos and footages, as the case may be, for publicity purposes or otherwise participate in the publicity activities of NEA in relation to the Contest and Draw and to the use of any data provided by such Winner for any future publicity efforts by NEA, without any payment or compensation thereof.
20. The decisions of NEA on all matters relating to this Contest and Draw are final, conclusive and binding. No correspondence will be entertained.
21. Notwithstanding anything in these Terms and Conditions, NEA reserves the right at any time in its absolute discretion to determine and/or amend, by addition to, subtraction from or variation of, these Terms and Conditions without prior notification, including but not limited to the eligibility terms and criteria, the selection of winners, the timing of any act to be done and all Participants to this Contest and Draw shall be bound by these amendments. All changes will be posted on the Website.
22. A person who is not a party to these Terms and Conditions shall have no right under the Contracts (Rights of Third Parties) Act to enforce any of these Terms and Conditions.
23. In the event of any inconsistency between these Terms and Conditions, any brochures, marketing or promotional materials relating to the Contest and Draw, these Terms and Conditions and all its subsequent variations shall prevail.

24. These Terms and Conditions and all its subsequent variations shall be subject to, governed by and interpreted in accordance with the laws of the Republic of Singapore.
